Subject: "Notification" for 5th All India Conference/ General Body meeting (Election) Issued by SEWA BSNL CHQ - Reg.

Kindly find enclosed herewith a copy of the Notification dated 01.03.2018 issued by President and General Secretary, SEWA BSNL CHQ, Governing body on the subject cited above. As per the notification, 5th All India conference/ General Body Meeting and election for new CHQ Governing Body of the Association is to be held on **17.04.2018 and 18.04.2018 at CTO Auditorium, Eastern Court, New Delhi.**

In view of the above, it has been decided to request you to undertake following activities for free and fair election:-

- 1) LO of your circle may be directed to update Name, Design, Mob no, office no, Fax no, Residence no., and Email ID of Dy LOs of SSAs under your jurisdiction.
- 2) The monthly subscription deduction from salary for SEWA BSNL will be taken for consecutive 3 months i.e. January 2018, February 2018 and March 2018 for becoming eligible to participate in selection/election of delegates. The concerned Dy. L.O will take the list of bonafide members from pay disbursing officer/ERP section and will circulate.
- 3) Selection/election of delegates will be conducted by SEWA in the presence of Dy LO as per the model guidelines issued by BSNL CO and provisions laid down in the bye laws of SEWA BSNL.
- 4) The concerned Dy L.O will be responsible for free and fair selection/election of delegates as per the model guidelines and bye laws of SEWA BSNL.
- 5) The selection and election of delegates may be conducted by SSAs(Districts) **between 01.04.2018 and 08.04.2018.** The list of delegates duly signed by Dy L.O and scanned copy should be sent to concerned L.O by **09.04.2018 positively.** However, the concerned Dy.LO will preserve the original documents to furnish BSNL Corporate Office, if required
- 6) L.Os of Circles should compile the received delegate lists from Dy.L.Os. And after signing the compiled delegate list, send the same in soft copy to GM & CLO (SCT), New Delhi and LO (SCT) O/o CGM, NTR Circle New Delhi by **12.4.2018, positively.** However, the concerned LO will preserve the list of delegates received from Dy L.Os.to furnish BSNL Corporate Office, if required.
- 7) All the members of SEWA, BSNL are advised to follow the BSNL CDA (Conduct) Rules. In case of any violation of Rules, disciplinary action will be applicable strictly.
