**Subject:** Implementation of the Hon'ble High Court of Kerala's Common Order dated 05.06.2018 in OP (CAT) No.25, 45 & 126 / 2015 (Madhu Mohan. H &ors Vs. BSNL &Ors) arising out of OA. No 185 &1081 of 2013 and 553 of 2015- Regarding preparation of revised AIEL.

I have been directed to refer to the above subject and to say that Seniority-cum-fitness promotion order for vacancy years 2009-10 & 2010-11 (under 67%) quota has been issued vide this office order no. 2-3/2018-Pers. II dated 15.06.2018. In this regard, it is further stated that the All India Eligibility List had to be redrawn as per the Hon'ble court order by way of classifying the JTOs figuring in the AIEL circulated vide No.2-18/2007-Pers-II(Pt.I) dated 20.02.2015 as below:

- (i) DoT recruited JTOs prior to the formation of BSNL on 01.10.2000,
- (ii) Promotee JTOs appointed against their own quota up to the year 1999 i.e. prior to the formation of BSNL
- (iii) Directly recruited JTOs of BSNL after the year 2000, and
- (iv) Promotee JTOs from DoT in excess of the promotion quota from 2001 onwards.


According, in view of the Hon'ble Court judgment dated 05/06/2018, only the JTOs falling under aforementioned first two clauses were considered for promotion to the grade of SDEs(T) against the vacancy years 2009-10 & 2010-11.

2. Now, as per the Hon'ble court direction the inter-se-seniority of the JTOs who fall under clause (iii) and (iv) is to be assigned seniority in their own respective classes as per quota-rota process in 1:1 ratio.

3. Keeping above in view, it is requested to furnish the gradation particulars of the promotee viz-a-viz DR-JTOs in the attached Annexure-I towards the preparation of the next AIEL as per the direction of Hon'ble High Court, Ernakulum latest by 20/07/2018.
