Respected Sir

I received representations from our members regarding the subject cited above which is self explanatory that reservation roster 15% for the SC candidates and 7.5% for ST candidates and own merit criteria as per Hon'ble Supreme Court order dated 17.05.2016,05.06.2018 and DOPT order dated 15.06.2018 have not been followed.

As per your AGM/Executive Engineer(Electrical) promotion order dated 29.06.2018, last O/C candidate is placed at Sr.No.122. So all the candidates irrespective of category comes before that will comes under open category. 15 % of SC i.e. 24 candidates and 7.5% i.e. 12 Nos of ST candidates should have come in

the list but you have given only 2 candidates from SC and 2 candidates from ST category. So there is shortfall of 22 SC candidate and 10 ST candidates.

I therefore request you kindly adhere the Hon'ble Supreme Court and DOPT guidelines and issue the subsequent promotion order for 32 SC/ST candidates immediately and extend the natural justice please.
