Pers. Section vide above referred letter has asked Screening Committee Report (SCR) in respect of all OC category SDE (T) in list -8. In this regard it is stated that vide our above referred letter of even number dated 03.7.2018 we requested your kind-self to arrange to issue instructions for asking VC & Assessment Sheet / APAR etc. in respect of SC/ST executives in list-9 in case all OC candidates of list-8 are considered for promotion to the post of AGM. ignoring our submission, has not called the Screening Committee Report (SCR) in respect of SC/ST executives of list-9.

It is relevant to mention here even as Pers. Cell has called for SCR for all OC Candidates of list 8, the existing vacancies of SC/ST candidates of List 8 has not been filled yet. Pers. Cell has been issuing promotion orders in piece meal for SC/ST executives even after continuous pursuance by us and still many names of eligible executives of SC/ST are missing. There is shortfall of SC (396) & ST (259) Total 655 executives for the promotion to the post AGM taking into account the total executives of OC category promoted till dated 6.7.2018 from list 5, 6, and 7.

Therefore, it is humbly requested that first the shortfall of SC/ST executives should be completed from list 8 and simultaneously initiate similar action of calling SCR in respective of SC/ST executives in List-9 without further delay.
