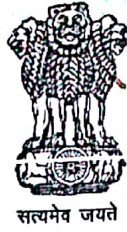

Dear Shri *Srivastava*,

Please refer to the DoT order No. 9-5(1)/2016-Estt dated 29.12.2016 with regard to the no. of ITS posts to be operated in BSNL on temporary and diminishing basis. A comparative statement of the no. of posts of ITS officers to be operated in BSNL vis-à-vis actual no. of ITS officers serving in BSNL during 2018-19 is as below:

Grade	No. of ITS posts approved by Cabinet	No. of ITS officers actually posted (as on 26.06.2018)
HAG	00	07
SAG	299	281
JAG	213	306
Total	512	594

From the above table, it is observed that the actual no. of ITS officers who are still posted in BSNL is far more than the approved strength. ITS officers serving in BSNL in excess of the approved strength are required to be relived immediately.

2. Further, DoT is facing shortage of man powers in LSAs and other units. In view of these shortages, several transfer and posting orders have been issued by DoT HQs in JAG and SAG of ITS Group 'A'. However, despite lapse of more than 3 months, BSNL has not complied with these specific transfer orders in respect of 12 officers (list enclosed as Annexure).

3. As, retention of ITS officers in BSNL, beyond the diminishing reserve approved by Cabinet, is violation of Cabinet orders, may I request you to relive the excess ITS officers from BSNL including those listed above, immediately.
