

Subject: Amendments of Bye-laws of SC/ST Employees Welfare Association (SEWA) - Regarding

In continuation to this office letter No. 65-1/2019-SCT (Pt.I)/547 dtd 19.8.2019 on the subject mentioned above, the following amendments are brought in your notice for necessary action at your end:

Clause No	Existing Provision	Clause No	Amended Provision
1.(i)	Subscription: The Subscription for the members will be Rs. 10/- for Group-D and Group-C (Non executives) Rs.10/-for Group-B and Group-A(Executives)per month which will be paid upto the 10 th of every month.	1.(i)	Subscription: The subscription of the members irrespective of cadres will be Rs. 50/- which will be deducted from the salary of the members every month.
6.(i)	Meetings: The Governing body shall call at least one General body meeting of the Society in every two years	6.(i)	Meetings Tenure period of the elected body of SEWA at District, Circle, and CHQ (All Three levels) will be three years. The Governing body shall call at least one General body meeting of the society in every three years.
7(I)	Election The above members of the Governing body/Circle body/District body shall be elected at the General body meeting for the period of two years unanimously or by a secret Ballot papers , if required through delegates ,5% delegates for Circle and 2.5% for CHQ meeting allowed.	6(I)	Election The above members of the Governing body/Circle body/District body shall be elected at the General body meeting for the period of three years unanimously by inviting all the bonafide single members of the society or by a secret Ballot papers , if required through delegates ,5% delegates for Circle and 2.5% for CHQ meeting allowed.
