Election for Governing Body of SEWA CHQ shall be conducted strictly on the basis of Model guidelines formulated by SEWA CHQ, approved and circulated by BSNL Corporate Office only. The guidelines for conducting Election process will be issued in due course.

The list of 2.5% delegates of the Bonafide paid single members those who are attending the conference / General Body Meeting should be prepared and sent to the General Secretary by the respective Circle Secretaries/Authorised Circle Co-ordinators with full details of Single Members minimum 15 days in advance for assessing and for making better arrangements including food and accommodation. Eligibility Criteria will be fixed on the basis of May 2021 to July 2021 (Three Consecutive months) Subscription deduction from salary. No Mannual subscription will be taken into account for deciding strength of delegates.

Delegates / Observer fee per Delegate / Observer is fixed Rs.1500/- (Rupees One Thousand Five Hundred only) for two days. Please refer to your letter No. SEWA BSNL CHQ/2018-20 dated 10/06/2019 regarding submission of amended bye-law of SC/ST Employees Welfare Association, BSNL, which was passed in All India Conference/General body meeting of SEWA BSNL, and certified by the Registrar of Societies office of the SDM, Dwarka, New Delhi. Subsequently, a fresh letter No. SEWA BSNL CHQ/2018-20 dated 4/07/2019 has been received from you that Para-18 of amended bye-law regarding approval of SEWA CHQ by BSNL Corporate Office, may be treated as Recognition by BSNL Corporate Office. However, you may get it certified this para from the Registrar of Societies and intimate to this office immediately.

The said amended bye-law of SC/ST Employees Welfare Association, BSNL is acknowledged by this office.

Further, consequent upon introduction of amended bye-law as above, the following letters/

circulars issued by BSNL stand withdrawn with immediate effect:

Note: In addition to above, letter/ circular related to election of SEWA, BSNL, if any, issued by BSNL may also be treated as withdrawn.

Beside above, as has been agreed by you and considering various representations, the following guidelines may be taken care for better coordination with the Management:-

- i) Functioning of SEWA including election, inter-relation and control among various layers of SEWA
   i.e. CHQ, Circle & SSA level shall be governed by SEWA bye-laws as amended from time to time.
- ii) SEWA, BSNL may ensure timely election of SEWA body as per SEWA bye-laws. In case tenure of SEWA body of any level, is ended and no election is conducted within one month from the end date of tenure, the facilities provided by BSNL will cease to exist. However, SEWA may submit justification for delay of election for restoration of the facilities with a realistic time lines schedule for election. Facilities will be restored for 3 months at a time.

- iii) In case election procedures are silent on some issue in existing SEWA bye-laws, the SEWA body will make its own provisions/procedures for conduct of free and fair elections. In this regard, no assistance shall be provided by BSNL in any manner.
- iv) Correspondence of SEWA with BSNL Management will be entertained only from General Secretary SEWA CHQ with Corporate Office, Secretary SEWA Circle with Circle Management and Secretary SSA SEWA with SSA Management.
- v) BSNL Management will deduct monthly subscription only from the employees (SEWA members) & deposit with SEWA. No other fees periodical subscription will be deducted and deposited by BSNL.
- vi) The role of BSNL Management in the election of office bearers of SEWA at different level will be similar to that in the election of office bearers of other trade unions and associations.
