Recently a meeting of all BSNL recognized associations and unions was held under the chairmanship of your kind-self on dated 26.4.2022 for reportedly sharing the latest developments / actions being taken by Govt. of India as well as various initiatives by BSNL Management for revival of BSNL. However, SEWA BSNL was not invited by BSNL Management in this meeting.

SEWA BSNL is also a recognized association and working very actively not only for the welfare of SC/ST executives but also for the interest of our beloved company BSNL. As soon as the notice for meeting issued by SR Cell, I personally met PGM(SR) and apprised the matter. PGM SR assured that the matter will be discussed with DIR(HR) and accordingly the decision will be conveyed to the undersigned in this regard. However, finally SEWA BSNL was not allowed in this meeting.

This is not first time when SEWA BSNL has been discriminated & demoralized but earlier also SEWA was deliberately kept away from the discussions / deliberations where presence of this association was essentially required. This issue was brought to the kind notice of your kind-self and Hon'ble Chairman, Parliamentary Committee on the Welfare
