In order to maintain focus on achieving the annual revenue targets and in supersession of the earlier instructions issued on this subject, it has been decided that inter-Circle and intra-Circle transfer & postings from the FY 2026-27 be carried out on an annual basis, preferably in the month of April or May. In case of exceptional exigencies, Circles shall obtain prior approval of this office before effecting such transfers.

- The online submission window for inter-Circle and intra-Circle transfer applications will now be opened once every year, from 1st January to 15th January, instead of on a six-monthly basis. Circles shall ensure that the career history and stay particulars of all employees are updated in the ERP system by 31st December of the preceding year.
- The timeline for processing transfer requests will be as under: 3.

- Applicants for inter-circle transfers shall indicate three choices of circles through OTP window, preferably opting for most deficient circles(s). Requests will be considered for the preferred circle(s) subject to administrative constraints.
- In case of intra-circle transfers, the Applicants shall indicate three choices of OA/BA/Unit within the Circle through the OTP window, preferably opting for most deficient OA(s)/BA(s)/Unit(s). Requests will be considered for the preferred OA(s)/BA(s)/Unit(s) subject to administrative constraints.
- Applicants may modify or withdraw the choices already submitted in previous or current OTP application during the open window period, in accordance with the instructions issued vide this office letter dated 24.01.2025 (Reference 2).
- Officers under transfer liability are advised to exercise OTP request preferably to 7. most deficient circle(s), well in advance and move out in their own interest so as avoid double transfer (intra and inter circle) within a short period.
